CEN Practice Answer/Rationale

Burst fractures of the vertebral body – (Rationale) Many cervical spinal cord injuries are the result of axial loading (head-first impact injuries). They result in burst fractures; this is an injury in which the vertebra (the primary bone of the spine) breaks in multiple directions.
